Interpreting a Wood Packaging Material (WPM) Fumigation Quality Mark



- a. Trademark – the identifying symbol, logo, or name of the accredited agency.
- b. Facility Identification – product manufacturer name, brand or assigned facility number.
- c. Fumigant mark (note – will be two letter code as designated in ISPM15. In these examples MB represents use of the fumigant methyl bromide).
- d. Country Code – the two letter ISO country abbreviation.
- e. Approved International symbol for compliant wood packaging material.
- f. Indication for use as dunnage (may be abbreviated or spelled out fully).

(These marks will be found only on lumber for use in construction of Fumigated WPM. Presence of these marks alone do not indicate products are acceptable for international shipment under ISPM-15 requirements.)



- a. Trademark – the identifying symbol, logo, or name of the accredited agency
- b. Facility Identification – product manufacturer name, brand or assigned facility number
- c. Fumigant mark (note – will be two letter code as designated in ISPM15. In these examples MB represents use of the fumigant methyl bromide)

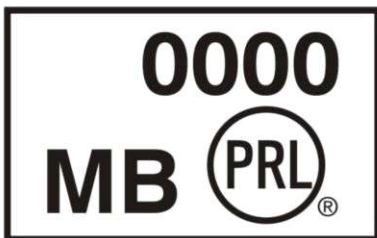

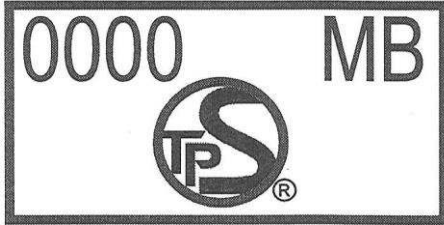
